

Census of Restricted Regime Prisoners April 2022

The result of the April 2022 survey shows that the number of prisoners on restricted regimes has decreased by **224** in the overall figure compared to January 2022 from **982** to **758 (April 2022)**, a decrease of **23%**.

In addition, those on a restricted regime for protection reasons (Rule 63) was **575**, (of which **563** were there at their own request).

The number of prisoners on **22 hour restricted regime** was **254**, which represents an increase of **48** on January 2022 of **206**.

The number of prisoners on **23 hour restricted regime** was **81**, which represents a decrease of **143** on January 2022 of **227**.

The number of prisoners on **24 hour restricted regime** was **76**, which represents a decrease of **177** on January 2022 of **253**.

Key Statistics

- **758** prisoners in total were subject to a restricted regime.
- **575** (14% of prison population 4,013) prisoners restricted on grounds of protection/vulnerability (Rule 63), of which 563 were there of their own request.
- **16** prisoners restricted on grounds of order (Rule 62).
- No prisoners were restricted due to medical reasons (Rule 64).
- No prisoners was restricted due to discipline (Rule 67, Part 3 Prisons Act 2007).
- **167** prisoners were restricted due to COVID-19 infection control measures introduced (i.e. Isolation and Quarantine (Rule 103)).

Covid-19 infection control measures captured under Rule 103 include:

- Quarantine of all new prisoners (testing of all new committals to the prisons is in place, which allow for prisoners to exit quarantine and enter the general population upon receipt of a negative result)
- Isolation of a suspected case or a prisoner with symptoms to prevent the risk of transmission of infection;

The restriction of a prisoner's regime can occur due to a number of factors including, medical reasons (Rule 64) and/or the protection of vulnerable prisoners. This is provided for under Rule 63 of the Prison Rules 2007. A prisoner may, either at his/her own request or when the Governor considers it necessary, in so far as is practicable and subject to the maintenance and good order and safe and secure custody, be kept separate from other prisoners who are reasonably likely to cause significant harm to him/her.

The fact that prisoners seeking protection are immediately separated from the general population or from specific prisoners identified as presenting a threat, clearly demonstrates the commitment of the Irish Prison Service to ensure their safety and security. The status of each prisoner on restricted regime within the prison system is regularly reviewed. If possible, prisoners can be transferred to other institutions where a restricted regime would not be necessary.

In addition, the Governor may decide, for the maintenance of good order in the prison, to remove a prisoner from general association or structured activity to reduce the negative effect that a prisoner or prisoners may have on the general population. This is provided for under Rule 62 of the Prison Rules 2007.
