

### **Census of Restricted Regime Prisoners January 2020**

The result of the January 2020 survey shows that the number of prisoners on restricted regimes has increased by **44** in the overall figure compared to October 2019. Figures show that there has been an increase from **545** (October 2019) to **589** (January 2020), an increase of **8%**.

The figure for those on a restricted regime for protection reasons (Rule 63) was **552**, (of which 533 were there at their own request).

The number of prisoners on **23 hour restricted regime** was **4**, which represents an increase of **4** on October 2020 of **0**.

The number of prisoners on **22 hour restricted regime** was **71**, which represents an increase of **21** on October 2019 of **50**.

**Since the commencement of the survey in July 2013, the number of prisoners on 22/23 hour, restricted regime has decreased by 136 or 64% from 211 to 75.**

#### **Key Statistics**

- 589 prisoners in total were subject to a restricted regime.
- 552 (14% of prison population 3,999) prisoners restricted on grounds of protection/vulnerability (Rule 63), of which 533 were there of their own request.
- 36 prisoners restricted on grounds of order (Rule 62).
- 1 prisoners was restricted due to medical reasons (Rule 64).
- 0 prisoners were restricted due to discipline (Rule 67, Part 3 Prisons Act 2007).

The restriction of a prisoner's regime can occur due to a number of factors including, medical reasons (Rule 64) and/or the protection of vulnerable prisoners. This is provided for under Rule 63 of the Prison Rules 2007. A prisoner may, either at his/her own request or when the Governor considers it necessary, in so far as is practicable and subject to the maintenance and good order and safe and secure custody, be kept separate from other prisoners who are reasonably likely to cause significant harm to him/her.

The fact that prisoners seeking protection are immediately separated from the general population or from specific prisoners identified as presenting a threat, clearly demonstrates the commitment of the Irish Prison Service to ensure their safety and security. The status of each prisoner on restricted regime within the prison system is regularly reviewed. If possible, prisoners can be transferred to other institutions where a restricted regime would not be necessary.

In addition, the Governor may decide, for the maintenance of good order in the prison, to remove a prisoner from general association or structured activity to reduce the negative effect that a prisoner or prisoners may have on the general population. This is provided for under Rule 62 of the Prison Rules 2007.

The Director General of the Irish Prison Service chairs a high-level group, which looks at measures which can be introduced to reduce the number of prisoners currently held on restricted regimes and monitors Census results and returns from individual prisons.
